## CIRCULAR

**Sub: Counselling cum Admission at NERIST through JoSSA/CSAB NEUT counselling – 2024- reg.**

This is for information to all the candidates who has have received the seat allotment letter for admission at NERIST for B.Tech. courses through JoSSA/CSAB & CSAB NEUT Counselling that they may physically report to the Institute from 22.07.2024 onward for admission with all the original documents and the photocopies of the same.

Candidates are required to fill up the Counselling-cum-Admission form by registering at <https://students.targetx.in/NERIST/> from 12<sup>th</sup> July 2024 onward and by paying a non-refundable counselling fee of Rs 500.00 only. Candidates are required to submit the completed form and get all the documents verified IN-PERSON w.e.f. 22.07.2024. Candidates must register with a valid email address and mobile number as all correspondence will be made to those contacts. These email and mobile numbers will be considered as your registered contact with NERIST once you are admitted.

Candidates are required to bring the following documents for physical verification:

1. Class X, XII, and Diploma Pass Certificate, as applicable; Migration Certificate, Institute Leaving Certificate, Mark Sheets of all Semesters of Diploma, etc. The aggregate marks for Diploma 3-years should be 60% or above.
2. SC/ST/OBC/EWS/PWD certificate (if applicable) issued by the Competent Authority (Deputy Commissioner or an Authorized Revenue Officer) in support of your claim. PWD candidates must bring a proper Medical Certificate clearly mentioning the locomotor disability and its percentage. For OBC candidates, the Non-Creamy Layer (NCL) Certificate, along with an OBC certificate, is a must. The NCL/EWS Certificate should not be older than a year from the date of its issue. The EWS certificate should be as per the format issued by the Govt. of India.
3. A Permanent Resident Certificate (PRC) is mandatory if you have applied for the state quota of the North East Region. The certificate should be issued by Competent Authority (Deputy Commissioner or an Authorized Revenue Officer) and bear the name, designation, signature with date, and office seal of the issuing officer.
4. Copy of the JEE Main Score Card.
5. Provisional Seat Allotment Letter issued by JoSSA/ CSAB NEUT/ DHTE/DTE.
6. Self-attested copy of Aadhaar Card of the candidate.
7. A scanned copy of the Candidate's Bank Pass Book, if available, or else the student is required to open a bank account in the SBI NERIST branch after admission.
8. Family Income Certificate from the Competent Authority of the respective District. (can be submitted after admission)
9. Medical Fitness Certificate of the candidate.

Further, the **admitted students** are required to fill out an Online Anti-Ragging Undertaking on either of the following websites: [www.AMANMOVEMENT.org](http://www.AMANMOVEMENT.org) or [www.ANTIRAGGING.in](http://www.ANTIRAGGING.in). The hard copy of the undertaking, as received by email, should be submitted to the Academic Section and Nodal Officer Anti-Ragging at the time of semester registration every year. **As the regular classes are scheduled from July 25<sup>th</sup>, 2024, the students are advised to complete the admission formalities as early as possible to join the regular classes.**

## GUIDELINES FOR FILLING UP THE COUNSELLING CUM ADMISSION FORMS:

Candidates are required to fill up the Counselling-cum-Admission 2024 form by registering at <https://students.targetx.in/NERIST/> from 12<sup>th</sup> July 2024 and by paying a non-refundable counselling fee of Rs 500.00 only. Candidates are required to submit the completed form and Candidates are required to submit the completed form and get all the documents verified **IN PERSON** at NERIST w.e.f. 22.07.2024. You must register with a valid email address and mobile number as all the correspondences will be made to those contacts.

If you encounter any problems during form completion, click on the “Query” button at the bottom of the left panel to raise a query, and we will respond to it through your registered email. Also, keep checking the Instruction and Notification sections on the left panel and the NERIST website (<https://nerist.ac.in>) regularly for updates.

The following points are to be noted in connection with counselling/admission:

- (i) **Not filling up Counselling-cum-Admission form before the scheduled counselling date/time and/or your absence in offline counselling on the prescribed date and time will be presumed as “Not Interested” in getting admitted to this Institute, and accordingly, your candidature shall be forfeited for admission automatically.** In such case, no requests for further consideration shall be entertained in any form.
- (ii) Any deficiency in the documents, as stated above, shall lead to the rejection of your candidature.
- (iii) **All the documents will be verified before admission. In case of any deficiency in your documents at the time of admission or furnishing forged/false/incorrect statements/ documents at any stage after your admission/registration to this Institute shall result in the cancellation of your admission.**

## Fee Details:


For admission to the allotted branch as per the Provision Letter of Allotment issued by JoSAA/CSAB NEUT /DTE, the candidate must pay the following fees ONLINE immediately upon allotment of a seat by NERIST after verification of documents in the Institute.

- (a) The Academic/Semester fee of **Rs 21,990/-** (approx.) for Degree Courses is to be paid ONLINE by logging into the same account at <https://students.targetx.in/NERIST/login>. We accept all forms of online payments (Credit Card/ Debit Card/ATM Card/Net Banking/ Wallets/ Cash Cards/ UPI (for a full list of supported UPI Apps, refer to <https://www.npci.org.in/what-we-do/upi/live-members>).
- (b) Mess Advance of **Rs 16,610/-** (approx.), and Hostel Caution Money of **Rs 3,000/-** by logging into Hostel ERP (<https://erp.nerist.ac.in/student>). After login, navigate to the Payment & Dues page (yellow icon on the top-right corner with INR symbol). We will provide you with the login credentials for NERIST ERP via SMS/email to your registered mobile number/email address after admission.

Since NERIST is a fully residential Institute, all the students are required to stay in the Institute’s hostels only, which will be allotted at the time of admission. The candidates are advised to bring their bedding, clothing, mosquito net, etc., while coming to stay in the hostel. **The Freshers’ Orientation Programme** will be held on **2<sup>nd</sup> August 2024** from 4.30 PM onwards.
