North Eastern Regional Institute of Science & Technology, Nirjuli, Itanagar, Arunachal Pradesh-791 109 should submit the Compliance report at least 6 months before the expiry of validity of accreditation mentioned above. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the programme (s) accredited level of programmes and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programmes is subject to change on periodic review, if needed by the NBA.
