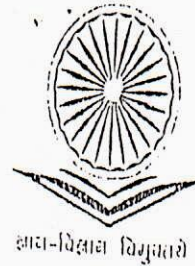

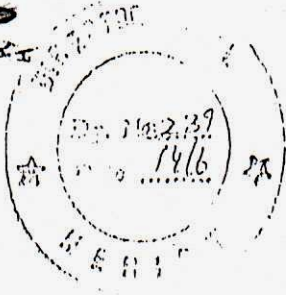

NOTIFICATION

In exercise of the powers conferred by Section 3 of the University Grants Commission Act, 1956 (3 of 1956), the Central Government, on the advice of the University Grants Commission, hereby declares the North Eastern Regional Institute of Science & Technology, Itanagar, Arunachal Pradesh as Deemed to be University for the purpose of the aforesaid Act with immediate effect subject to the following conditions: -
