## NOTIFICATION


The Ministry of Home Affairs, Govt. of India vide order No. 40-3/2020-DM-1(A) dated, 29/08/2020 has issued directives and guidelines on unlock 4 which will be in force upto 30/09/2020. As per the said guidelines, Colleges and educational institutions will remain closed till 30.09.2020. In pursuant of the aforesaid order, **all classes of the Institute will remain closed till 30/09/2020**. Online/distance learning shall continue to be permitted and shall be encouraged. It has been further stated that for research scholars (Ph.D.) and post graduate students of technical and professional programmes requiring laboratory/experimental works, these will be permitted by the Department of Higher Education (DHE) in consultation with MHA, based on the assessment of the situation and keeping in view incidence of COVID-19 in the States/UTs. However, Institute **office will function normally** and activities as permitted outside the containment zone will be performed by maintaining social distancing, wearing of face cover, sanitisation of workplace and by following Standard Operating Procedures (SOPs) as prescribed by the Ministry of Health and Family Welfare (MoHFW) Govt. of India.

Further, National directives for COVID-19 management, as specified in Unlock 4 (Annexure I), issued by the MHA, Govt. of India dated, 29/08/2020 must be strictly complied.
