for development of various infrastructure sectors in the state through much-needed infusion of resources and managerial capability of the private sector. It will require lots of technical help. He expressed his hope that NERIST will

learn, perform challenging work in industry and work sites and gain substantive professional experience. He suggested that the premier technical institute should collaborate with other universities within the country and outside and create online networks for knowledge sharing. Maintaining that experienced engineers working along young engineering students and local residents can develop workable solutions for areas where working conditions are tough. Through a cross-disciplinary approach, the Governor also suggested for creating network alumni. He also highlighted importance to extra-curricular activities. (Speech of H.E. Governor is annexed herewith as 'A'.)

After concluding his address, His Excellency invited the Director, NERIST to present the Director's Report before the august house.

Director, NERIST thereafter submitted his report to all the Hon'ble members present in the meeting and conveyed few important points.

At the outset the Director pointed out that last (19<sup>th</sup>) AGM of NERIST Society was held on 22<sup>nd</sup> June, 2010 and since then, the Institute did average in terms of academic activities. A few post graduate programme were started



and construction of new girls' hostel and transit hostel started. These are stated in brief as follows:

**(a) Academic :**

1. Academic achievements since last meeting of NERIST Society.

Director, NERIST stressed the need to pay immediate attention of faculty recruitment, retention and promotion of faculty to maintain cadre

ratio, recruitment of technical manpower to support laboratories, maintenance of laboratories, procurement of laboratory-equipment, software and chemicals, to improve the overall teaching-learning process, improvement of internet service, e-campus and most important students' placement through campus selection. He stressed the need to pay attention to the issue of severe shortage of general and administrative manpower in various cadres in order to avoid a situation where a single officer is forced to hold multiple positions.

Director NERIST said campus maintenance, planning and development work keeping the infrastructure requirement for next 10 years should also start now as we are zeroing on the start of the 12th five-year plan-period starting from 1<sup>st</sup> April, 2012.

### **(C) Infrastructure Development**

Building and construction and development work since last meeting of NERIST-Society.

- (i) A new 200 capacity Girls' Hostel is under construction.
- (ii) Transit Hostel (Continuing Education Programme) is under construction.
- (iii) A 1200 kilo liter overhead tank is under construction.
- (iv) The Silver Jubilee Hall (Auditorium) work had been awarded to NPCCL for construction. The work was first approved by 29th FC and 66th BoM and then re-examined by experts from IIT, Guwahati as per the recommendation of 69th BoM and finally been approved by 33rd FC and 71st BoM for total outlay of Rs. 1,850.00 lakh. The work is expected to start during 12th five-year Plan.

## 2. Issue of AICTE Approval:

[NERIST has been declared a deemed university on 31<sup>st</sup> May, 2005. Therefore, it does not need AICTE approval for the different programmes run by it and/ or introduced by it from time to time with the approval of the Academic Council/ Board of management/ Society of the Institute. On the contrary as a deemed university it needs UGC approval/ guidelines to follow. If the Society passes a resolution prompting this change the Institute can take it up with their end.]

**Resolution:** Members opined that for technical courses, the approval of AICTE may still be taken in view of the institutional interest.

## 3. Issues of Petty Construction Work of NERIST:

[ The Institute has been facing regular pressure from local people who demand that works of petty civil construction should be given to them through Contractors' Welfare Association (a registered body of local contractors) without tendering. This however has faced severe objection from the office of the Auditor General of Arunachal Pradesh. Moreover, some of the local contractors do not have proper registration, PAN etc. As such the present Director had initiated the process of tendering for awarding all items of civil construction works including petty works up to Rs. 10 lacs, as per norm. However, due to law and order issues created by some dis-satisfied contractors, the tendering had to be stopped recently in two such cases till further notice. As a result a stale-mate is created particularly for petty construction work. This assumes further significance as weather condition for construction work is possible in this area only during winter months.]

**4. Encroachment in 240 acre Hill Top Campus.**

[It was pointed out that there is encroachment in the 240 acres of allotted to NERIST and Institute should take deterrent steps for possession of the land and construction work of compound wall. The work has been approved by the 33rd FC, 71st BoM subject to availability of fund.]

**Resolution:** Issue of the 240 acre was informed by the Director and it has been noted, that there is a huge number of encroachment. Chairman directed that there should not be any further new encroachment. There is a need of watch tower in 240 acres land to avoid new encroachment in near future. The construction of boundary wall can be started as soon as possible with support from local administration to maintain law and order and also to reach out to local citizens.
