NOTIFICATION

In pursuant to the Ministry of Home Affairs, Govt. of India, notification dated, 24/03/2020 and further modified on 25/03/2020 and 27/03/2020 and in pursuant to Cabinet decision dated 13/04/2020, Government of Arunachal Pradesh and in compliance of announcement for extension of national lockdown till 03/05/2020 by the Hon'ble Prime Minister of India on 14/04/2020 for containment of COVID-19, Offices of the Government of India, its autonomous/subordinate offices and public corporations shall remain closed till 03/05/2020". The North Eastern Regional Institute of Science and Technology (NERIST), Nirjuli, Itanagar, Arunachal Pradesh, being an autonomous Institution under Ministry of Human Resource Development, Department of Higher Education, Govt. of India, in compliance to the above, the Institute will remain close till 03/05/2020 and will observe complete lockdown during the said period. All classes and academic schedule will remain suspended. However, the essential services as allowed by the Govt. will remain in place maintaining social distancing. Further, the ongoing construction/infrastructure related works, where workers are already available would be allowed to resume the works. No new workers will be allowed from outside the state or from other districts as per Clause 6 (d) of Cabinet decision dated, 13/04/2020, Government of Arunachal Pradesh.
