OFFICE ORDER


The Government of Arunachal Pradesh, Department of Education vide order No. ED/HE-06/2008, dated 29/12/2020 has notified the standard operating procedure **for reopening of all HEIs** (all types of universities/colleges/polytechnics) in the State of Arunachal Pradesh to maintain all the protocols and safety guidelines under COVID-19 pandemic. The standard operating procedure has come into force with effect from 05/01/2021. However, **NERIST being fully residential Institute will open only** after an specific notification for reopening of hostels is received from the Govt. of Arunachal Pradesh and Department of Education, Govt. of India. Hence, **all offline classes of the Institute will continue to remain suspended till further order.** Online/teaching learning shall continue to be the preferred mode of teaching and learning and shall be maintained. Institute **office will function normally** and activities will be performed by maintaining social distancing, wearing of face cover, sanitisation of workplace and by following Standard Operating Procedures (SOPs) as prescribed by the Ministry of Health and Family Welfare (MoHFW) Govt. of India.

Further, National directives for COVID-19 management, as specified in Re-opening (Annexure I), issued by the MHA, Govt. of India dated, 30/09/2020 must be strictly complied.
