**NOTIFICATION**


The Ministry of Home Affairs, Govt. of India vide order No. 40-3/2020-DM-1(A) dated, 30/09/2020 has issued directives and guidelines on Re-opening. As per the said guidelines, Colleges and educational institutions will remain closed till 15/10/2020. In pursuant of the aforesaid guidelines, **all classes of the Institute will remain closed till 15/10/2020.** Online/distance learning shall continue to be the preferred mode of teaching and shall be encouraged. It has been further stated that the decision regarding Re-opening of the Institute and activities of research scholars (Ph.D.) and post graduate students in science and technology stream requiring laboratory/experimental works will be taken after 15/10/2020 by the Department of Higher Education (DHE) in consultation with MHA, based on the assessment of the situation and keeping in view incidence of COVID-19 in the States/UTs. However, Institute **office will function normally** and activities as permitted outside the containment zone will be performed by maintaining social distancing, wearing of face cover, sanitisation of workplace and by following Standard Operating Procedures (SOPs) as prescribed by the Ministry of Health and Family Welfare (MoHFW) Govt. of India.

Further, National directives for COVID-19 management, as specified in Re-opening (Annexure I), issued by the MHA, Govt. of India dated, 30/09/2020 must be strictly complied.
