TERMS OF REFERENCE

1. The Committee will address various grievances of the students.
2. Any aggrieved students may lodge their complaint to the Chairperson SGRC.
3. The quorum for the meeting including the Chairperson, but excluding the special invitee shall be the three.
4. The term of members and special invitee shall be of two years.
5. In considering the grievances before it, the SGRC shall follow principles of natural justice.
6. The SGRC shall send its report with recommendations, if any to the concerned institution and a copy thereof to the aggrieved student, with in a period of 15 days from the date of receipt of the complaint.
7. Any students aggrieved by the decision of the student Grievance Redressal Committee may prefer an appeal to the ombudsperson, within a period of fifteen days from the date of receipt such decision.


