MANDATORY ACTIVITY

The conduct of online web based survey for Student, Faculty and Non-Teaching Staff Satisfaction Survey is part of the TEQIP-II activity as mentioned in the PIP. It is mandatory and it is part of the 12 performance indicators based on which the funds will be released.

The pilot survey was conducted in 8 institutions by M/s Infova Consultancy Services along with NPIU officials in August, 2014. Based on the observations and response received it was felt that regional workshops covering the SPFUs and 190 institutions of the project need to be conducted. Accordingly, 2 regional workshops have been organized and conducted at Bangalore (with the help of SPFU Karnataka) and 1 at Kolkata ((with the help of SPFU West Bengal). Another workshop is planned in Pune on 29th and 30th September, 2014 to cover the remaining institutions. The response of the workshops and Bangalore and Kolkata have been highly encouraging and the participants have assured that all out efforts will be made to get 100% participations of the population of the institutions.

The online web based survey for Student, Faculty and Non-Teaching Staff Satisfaction Survey will commence on 1st October, 2014 and is scheduled to be completed by 31st October, 2014.
