1. Tenders have to be submitted quoting the price offered both in figures and in words along with name and corresponding address of the Bidder with contact telephone number in sealed envelop to reach the office of the undersigned on or before 08/11/2023 up to 3.00 PM, inscribing “Tender for purchase of condemned/unserviceable items (mentioning the item for which tender is submitted on the top of sealed envelop)”.
2. Security Deposit of ₹50,000.00 (Rupees fifty thousand) only in the form of demand draft in favour of the Director, NERIST payable at SBI, NERIST (Code-18744) must be accompanied with each tender and the same is adjustable/refundable.
3. The Security Deposit will be retained till finalization of tender(s). The successful tenderer(s) shall have to deposit the full value of the bid scraped items within three (3) days of time from the date of acceptance of the offer by the competent authority failing which the offer will be treated as cancelled and the Security Deposit deposited will be forfeited and the materials would be disposed off in any manner at the discretion of the competent authority.
4. The materials shall have to be removed immediately within the three (3) days after the competent authority accepts the full payment.
