**AC 16.1 To consider confirmation of the Minutes of the 15<sup>th</sup> Academic Council Meeting held on 25.08.2012.**

[Note: The minutes of the 15<sup>th</sup> Academic Council Meeting held on 25.08.2012 was circulated to the Hon'ble members on 12.09.2012.

Only one comment was received from Prof. Rajendra Prasad, Deptt. of Physics on the resolution of Agenda Item No. AC.15.3(a) regarding proposal for Centralized Entrance Examination for PG & Ph.D. Programmes. Constitution of a committee under the Chairmanship of Prof. Rajendra Prasad was reported in the minute to finalise the modalities for Centralized Entrance Examination for PG & Ph.D. Programmes. Whereas, Prof. Rajendra Prasad, observed that no such committee was constituted in the previous meeting. qualification prescribed for the post. Mr. Abhineet Kumar has a Base Module certificate issued by NERIST which is not recognized by the SSC].

**AC 16.10- Course work on "Research Methodology".**

[Note: The Dealing Assistant (Ph.D. Cell) pointed out that as per UGC (Minimum Standard and Procedure for award of M.Phil (Ph.D. Degree) Regulation, 2009 a student is required to undertake course work for a minimum period of one semester. The course work must include a course on research methodology which may include quantitative methods and computer application. However, this condition is not included in our course work. Some students have already completed the course work and some are in verge of completing. So they are worried whether they are still required to complete the course work on research methodology or not].

The Academic Council may deliberate and decide appropriately. **Annexure – X.**

**Resolution :** The student should register for the Research Methodology course as it is mandatory for the Ph.D. programme, recommended by the UGC 2009 regulation and it should be included in the Ph. D Academic Bye Laws. To avoid any problem in future the students who have already cleared their course requirement should be advised to take the course as a mandatory requirement.

In case of HOD/HOC not having Ph.D. degree Head of allied department holding Ph.D. degree should be Chairman of DC alternatively the department may invite an external member having Ph.D. degree for this purpose.


- AC. 16.12** To consider the recommendation of 24<sup>th</sup> BPGS at Agenda Item No. 12 and Minutes of the DPGC dated 16.03.2013 submitted by the Centre for Management Studies for introduction of MBA (Part time) from 2013-2014 academic session:

[Note: The resolution of the 24<sup>th</sup> BPGS on Agenda Item No. 12, and the DPGC minutes dated 16.03.2013 of the Centre for Management Studies regarding Eligibility criteria, Fee structure, Intake, Duration of the programme, Selection procedure, Course structure and proposed cost estimation, etc. for MBA (Part Time) are placed at Annexure. The DPGC has also recommended for the upgradation of nomenclature from "Centre for Management Studies" into a full fledged "Department of Management Studies", just like all IITs and NITs].

**Resolution: Till further recruitment of Faculty members in ECE Deptt. is done the M.Tech. in ECE programme is suspended. However, M. Tech. in VLSI will run.**

**AC.16.14 – To consider conducting SHRISTI along with RACAF by adding one more day in the schedule of RACAF.**

[Note: In a meeting held between Dean(SA), Chief Coordinator, Shristi-2013, President SUN, Secretary SUN in presence of Director, NERIST, it was agreed to conduct Shristi along with RACAF by adding one more day in the schedule of RACAF from the session 2013 – 2014 onwards as (i) there is no specified fund for Shristi. The EAC fund collected from students and matching grant provided by the Institute is meant for RACAF and Sports Club activities including the publication of ALTIUS and augmenting the facilities of Gymkhana. Till now institute has been providing separate fund for Shristi from Institute fund. (ii) some programmes of RACAF and Shristi were observed to be common during the last few years, (iii) there is no specified functionary identified for conducting Shristi, every year a functionary needs to be appointed for which choices are limited].

The Academic Council may consider the proposal and if approved the Chairman, Gymkhana may also be assigned with the responsibility of Shristi and provide additional fund required for Shristi.

The Academic Council may deliberate and decide appropriately. **Annexure – XIV.**

**AC.16.15 - (a) To consider approval of Research Methodology syllabus for Ph.D. in Forestry.**

[Note: The Board of Studies of Forestry Department has drafted the syllabus of Research Methodology for the Ph.D. students. The comments of internal and external members of Board of studies have been incorporated in the syllabus].

[Note: To make the students eligible for the position of Assistant Professor in various universities as per the UGC Regulation, 2009, the following categories of students may be given a chance to register for the Research Methodology course:].

- (i) The students pursuing Ph.D. degree but already completed 12 credits courses without Research Methodology and passed the comprehensive examination.
- (ii) The students already awarded Ph.D. degree (with 12 credits courses but without Research methodology) by NERIST in 2011 and 2012 and going to be awarded Ph.D. degree shortly.

**(C) To consider approval of change of title of Course FR-4204, Forest Tribology & Ethnobotany which is offered to B.Sc. Forestry.**

[Note: The Course FR-4204 Forest Tribology & Ethnobotany which is offered to B.Sc. Forestry mismatch with the contents of the course, new course title Tribal Studies & Ethanobotany is approved by BoS of Forestry department]

**Resolution: Approved. For similar cases the other departments should implement with the recommendation of their respective BoS and then place in the AC as reporting item.**

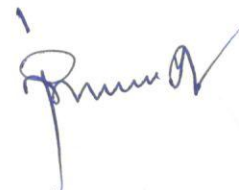
**AC. 16.16 - To consider correction in the present Under Graduate Academic Bye-Laws.**

[Note: A note received from DR(Acad) stating that in the new UG Academic Bye-Laws it is wrongly written that “a student may be allowed to change his/her discipline at the end of the 1<sup>st</sup> semester in the Base Module if vacancies exist in the desired discipline provided that he/she secures a CGPA of 4.75 (having GPA of 4.75 in each semester of 1<sup>st</sup> year).”

Whereas, it should be “a student may be allowed to change his/her discipline at the end of the 1<sup>st</sup> year in the Base Module if vacancies exist in the desired discipline provided that he/she secures a CGPA of 4.75 (having GPA of 4.75 in each semester of 1<sup>st</sup> year)” which needs to be corrected].

As NERIST and IIE, Guwahati, both are having the same mandate i.e. development of NE India, an MOU between them shall bring synergetic effect. IIE is having a similar MOU with many other premier Institutions of NE i.e. NEIST, Guwahati University etc.]

Deptt. of EE has requested that the same course may please be allowed to be registered by the M.Tech 2011 students in the current semester Jan-May 2013 so that the credit deficit could be made up and the students could complete the PG programme in normal academic schedule]. **Annexure – XXII.**

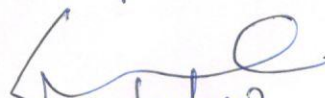
