His Excellency the Governor of A.P. and President of the NERIST Society Gen. J.J. Singh, PVSM, AVSM, VSM (Retd.) earlier in the day inaugurated the Bio fuel Demonstration Plant set up in NERIST campus Nirjuli at about 11.00 A.M. a pioneer Project under Mr.' Pradeep Lingfa, Associate Professor, NERIST with financial support from Department of Science & Technology(DST), New Delhi followed by inauguration of the Newly constructed Guest House building in august presence of Prof. Gautam Barua, Director, IIT, Guwahati and Chairman BoM, NERIST and accompanied by Shri Ankur Garg, IAS, Secretary to Governor, Dr. Joram Begi, Director, NERIST, invitees, officers and staff and students.

His Excellency arrived in the Board Meeting Room, NERIST followed by recitation of the National Anthem by K.V. students of NERIST.

Thereafter, Chairman called the meeting of the 19<sup>th</sup> AGM of NERIST Society to order and extended a warm welcome to the H'ble members and invitees in the Board Meeting Room of NERIST.

Dr. Joram Begi, Director, NERIST welcomed His Excellency the Governor of A.P. and President NERIST Society presiding over the society's meeting twice in succession. Director, NERIST then welcomed Prof. Gautam Barua, Director, IIT/Guwahati & Chairman, BoM, NERIST to this important meeting. Director NERIST also welcomed Madam Audrey Apang leading industrialist cum journalist of the region, Shri Basanta Kumar Singh – representative, state of Manipur and Shri M. Sora, Under Secretary, Education – representative, of Arunachal Pradesh and Shri Ankur Garg, IAS, Secretary to Governor of A.P., was as a special invitee to the meeting. their preoccupation with CABE meeting at Delhi, Assembly Session etc. Thereafter, Director NERIST requested His Excellency for his opening address.

The Chairman expressed his happiness to preside over the 19<sup>th</sup> AGM meeting attended by the distinguished members and lauded the leadership of Prof. Gautam Barua, Director, IIT, Guwahati and Chairman, BoM, NERIST and the Academic stewardship of Dr. Joram Begi in steering all-round development of NERIST as a Deemed University.

His Excellency observed that getting a university degree is not all that important but putting it into day-to-day use to improve upon the Society around and one's own family matters. Thereafter, His Excellency has delivered a speech on the occasion of  $19^{th}$  Annual General Meeting of NERIST Society which is attached at Annexure – 'A'.

After concluding his address, His Excellency invited the Director, NERIST to present the Director's Report to the august gathering.

Director, NERIST thereafter submitted his report to all the Hon'ble members present in the meeting and conveyed few important points of progress made after the 18<sup>th</sup> AGM of NERIST Society on 21.07.2009.

## (a) Academic:

1. Comprehensive revision of syllabi of all modules – Certificate/Diploma/Degree was completed after a gap of about 10 years by

following a rigorous procedure of Seminars/Conferences, discussion with external experts and approval of Academic Council. The new syllabi are coming into force in this Academic session 2010-11. In addition to the earlier started M.Tech. programmes in Civil & CSE and M.Sc. in Forestry Institute started full time M.Tech. programmes in 'all Engineering departments followed by M.Sc. programmes in Physics , Chemistry and Mathematics departments.

- 2. The centre for Management studies was separated from HSS Department with Prof. Prof. R.M. Pant, as the Head for creating management graduates proficient.
- 3. Institute introduced computerized evaluation of its NEE results for student's intake by declaring its results within 2 3 days of the examination with accuracy and transparency.

## (b). Administration:

Recruitment of faculty was done after many years replenishing the cadre strength exhausted to low levels due to migration to other institutions. A comprehensive advertisement no. 3/2010 was issued recently to recoup the cadre strength to 200 nos.

## 2. Departmental Promotion Committee:

Institute personnel were in deep legal litigation/invoking contempt jurisdiction on account of not conducting DPC's for Group C & D employees over a decade. Limited DPC's following the rationalized Staff Structure (RSS) not only restored normalcy in the campus but also could instill much needed confidence among the staff cadres.

#### 3. Rationalization of faculty Position:

Institute had been operating faculty cadre strength of 204 nos as per 1996 EFC provision. In pursuance of the recent MHRD orders limiting the faculty cadre strength to 200, the institute took up faculty rationalization by a committee and implemented the recommendation with approval of the last Board of Management.

#### 4. Networking of Campus:

Institute took up comprehensive net working of the campus including all Hostels, KV, NERIST and Residential areas enhancing the capacity from 2 MBPS to 16 MBPS to meet the communication needs.
