The meeting started with National Anthem.

At the outset, His Excellency the Governor of Arunachal Pradesh and President, NERIST Society, Lt. Gen. (Retd.) Nirbhay Sharma was warmly welcomed by Air Marshal (Retd.) Pranab Kumar Barbora,, Chairman, BoM, NERIST and Prof. Dipankar Pal, Director, NERIST. Then, Hon'ble President welcomed all members present in the meeting and expressed his happiness for attending the 22nd Society meeting of NERIST and declared the meeting open.

On a query from the Hon'ble President, NERIST Society regarding non attendance of all Members of the Society, Director, NERIST said that every time the meeting notice is sent to all members well in advance after getting approval of the date, time and venue from the Hon'ble President, NERIST Society and again members are reminded over phone also twice or thrice at least fifteen days before the Society meeting. Agenda papers are also sent to all members by speed post in order to reach them at least fifteen days before the date of the meeting for perusal of the Hon'ble members.

Director mentioned that all Education Ministers of all North East States are also the members of the NERIST Society. Even after reminding twice or thrice, only a few members attend the meeting. However, the meetings are conducted maintaining quorum as per MoA of the Institute. The Director showed the provision of the quorum in the MOA to the Hon'ble President. The meeting was continued.

Burgaseling

The President, NERIST Society asked the Director, NERIST to present a brief report through power point about the developments taken up during the period 2013.

## Director informed that

- Online submission of NERIST Entrance Examination Form was introduced last year and successfully done. On line submission of Post-Graduation Application Form will be introduced from next academic year.
- 2) Even though the strike call given by the Employees Union, the NEE examination was conducted without any hindrance.
- Conferences/Seminars/Workshops were conducted at NERIST by the faculty members in their departments. Many faculties also attended Conferences/Seminars/Workshops in order improve their skills.
- 4) Rupees Ten crore were released under TEQIP by the Government for academic and infrastructural development of the Institutes. Under TEQIP, Staff and Faculty Development Programmes were also conducted apart from Seminars/Conferences. Scholarship was also granted to the eligible PG students under TEQIP.
- 5) ATM facilities both SBI and Canara Banks were provided in hostel areas. LPG Gas shed is completed and formalities are on and as soon as the license from IOC is cleared, it will be opened to the residents of NERIST.
- 6) Construction of CEP building is under way by the APPWD.
- 7) Solar Photovoltaic Quality Generators were installed for supplying energy to street lights and academic block.
- 8) Renovation of ET Cell is completed with latest infrastructure in order to provide net connectivity to all hostels and offices round the clock.



- 9) Construction of girls' hostel with 200 capacities is nearing completion and would be ready for use by February, 2014.
- Construction of water reservoir with a capacity of 12 lakh liters is almost completed and quality water will be supplied very soon to all areas in NERIST.
- 11) Construction of Silver Jubilee Auditorium by NPCC is under way with an estimated cost of Rs.1798 lakhs.
- A2) Construction of 24 nos. of Class Rooms was approved by the Finance committee as well as Board of Management to award this work to the APPWD and the work was awarded to the APPWD and necessary MOU was also signed in this connection.
  - 13) Construction of 375 capacity of Boys Hostel was approved by the Finance committee as well as Board of Management to award this work to APPWD.
  - 14) Proposal for opening of new M.Tech courses in Food Processing and Technology under Agricultural Engineering Department and M.Tech. in Remote Sensing under CSE Department and M.Tech in Computational Linguistics is under active consideration of the Institute.
- 15) More Ph.D students had joined this year in comparison to previous year.

Director said that NERIST is going to conduct a two-day workshop on disaster management in a month or so in collaboration with Arunachal Pradesh State Government agencies by calling outside experts.

Institute is also planning to conduct coaching classes to the local youth who will appear for the entrance examinations to the IIT, Medical, Engineering and MBA etc through our faculty in holidays and after office hours and also planning to give

some training to the graduates to improve their computational skills in order to face interviews etc.

Director also said that NERIST will enhance net connectivity system throughout the campus. MHRD member said that a concrete proposal should be prepared and submitted to the MHRD for approval.

Hon'ble President appreciated the Director, NERIST for the developmental activities taken and said that NERIST as a technology Institute, should focus on research and development also apart from teaching and learning to the students. Further, he also emphasized that the research and development should be used for the development of the people of the area. He also stressed that awareness programmes also should be conducted in the villages so that it would become an opportunity to teach new things to villagers like rain water storage etc. He also emphasized that seminars and conferences should be conducted on the important thrust areas, which are useful for the people calling outside experts.

Director said that faculty in some departments already conducted awareness progreammes in the villages through their projects allotted by the Govt. of India. Director also said that consultancy services are also being provided by some departments like Civil Engineering and Mechanical Engineering etc.

Hon'ble President said that he would like to request Air Marshal (Retd.) Pranab Kumar Barbora, Chairman, Board of Management, NERIST to address on this occasion.

Chairman, BoM appreciated the developmental activities being taken up by the NERIST authority. He also echoed the views of the President, NERIST Society to enhance the research and development. He also appreciated especially for construction of girls' hostel, which is very essential to accommodate girls' students. He emphasized to see the students demands on priority and also appreciated the Director, NERIST for taking timely actions on the students' demands. He stressed on



constructing of model class rooms so that students can utilize the facilities without going outside.

Item No.SO.22.06.02: Status of various Developments activities (in the intervening period):

 To report on the issue of old Pension Scheme for NERIST employees (existing before 01.01.2014) and agitation by UNEUA (now NEA).

[Director explained the members that introduction of old Pension Scheme for those who joined on or before 31.12.2004 is an old demand and the authority is pressing hard to implement it at NERIST. The matter was placed in the 74<sup>th</sup> BoM held on 19.12.2012 and resolved that this should be implemented to the eligible employees and the matter was sent to the MHRD for final clearance. As the UNUEA went on strike on this demand, one order was issued initiating the process of implementation of GPF-cum-Gratuity-cum-Pension and issued on 26<sup>th</sup> April, 2013 with a copy to MHRD. MHRD, in turn, instructed to keep this order in abeyance. Thereafter reminders were sent to the MHRD seeking their final decision.

The UNEUA/NEA intermittently went on agitation on this issue during April, September and December, 2013 which had led to loss of man days. During 16<sup>th</sup> & 17<sup>th</sup> December, 2013, two representatives from MHRD visited NERIST to explain the stand of the MHRD on this issue. It was once again clarified by the MHRD that for pension issue, it is the Finance Ministry who has the authority to allow since the cut-off date is over. However, due to repeated persuasion from Director, NEA and other stake holders and in view of the documents already available with MHRD (submitted from the Institute at different times), it was decided that the MHRD will intimate its decision in next 60 days to Director with copy to NEA.

All members noted the point]

2. Conversion of concerned employees from 1/30<sup>th</sup> to Temporary status.

[Director said that as per the approval of the 75<sup>th</sup> BoM meeting held on 9.4.2013, the eligible 1/30<sup>th</sup> employees were converted into Temporary Status. The BoM also

[Director said that 21 contractual employees, all ST, were regularized after identifying the vacant posts through a two-member expert committee appointed by MHRD with the approval of the 75<sup>th</sup> Board of Management as a part of filling up ST posts. This matter was reported to the Society meeting. All members noted the point.]

## 4. Anomalies in implementing the order on resolving CAS anomalies for faculties.

[Director explained the members that some internal members raised the issue of CAS in the 78<sup>th</sup> BoM held on 30.9.2013 on the orders issued on 9<sup>th</sup> May, 2013 vide no. Est-101/2/2002/Vol-IV which were in violation of UGC/MHRD instruction stating undue benefit and subsequently the Board resolved to reexamine the financial part by outside expert / committee. Based on the decision of the Board and in line with the various observations from its Chairman, the institute decided to reexamine the orders in question. The orders those issued in this connection with it were kept in abeyance vide order no.EST-101/2/02/Vol-III dated 4.10.2013 while constituting a committee under the Chairmanship of Prof.L.S.Yadav vide Order No.Est-101/2/02/Vol.IV/4476-4481 dated 23.10.2013 to examine the financial aspect, to assess it and prepare the documents for further examination by outside expert committee as resolved.
