The 32<sup>nd</sup> Academic Council suggested that all HoD/HoC will return the corrected draft of Ph.D. Bye –Law by 15.01.2021 to the Dean (Acad) for final Printing.

Furthermore, students can also register by visiting the ABC website. A comprehensive User Manual for both HEIs and Students with step by step instructions and screenshots are available on the ABC portal's Resources section under the General Resources category. All eligible HEIs are requested to kindly take appropriate steps for joining ABC Platform at the earliest. Further, it is also informed to kindly make the students of your University/institution aware about ABC facility and encourage them for opening Academic Bank Account.]

It is to inform that as per the Institute notification (No.9) vide Acad/AC/25<sup>th</sup>/ATR/2017 dtd. 24<sup>th</sup> January, 2018, the Ph.D. fellowship (MoE/Institute scholarship) was restricted to 1(one) Ph.D. scholar for every Engineering Departments having valid GATE Score and GATE/NET/SLET score in Science / Humanities / Management, but in practice the NET/SLET holder are not being considered for the Institute fellowship. **AC. 33.11 To Consider the proposal for Counselling fee during Counselling- cum- Admission w.e.f next Academic Session.**

[Note: It is observed that Institute has put up tremendous efforts for smooth conduct of the Counselling-cum- Admission for UG and PG/PhD courses till date. However, it has also been felt that a counselling fee needs to be charged from the candidates on the lines of JoSAA and CSAB NEUT. This will help the committee to ascertain the actual number of students willing to attend the Counselling- cum-Admission. Further, the fee collected can be a source for Internal Revenue Generation (IRG) for the institute which can be also used to bear the expenditures incurred during the Counselling-cum -admission process. Hence, it is proposed that a one-time fee of Rs. 500/- (Rupees Five Hundred) only may be charged from the candidates who are going to attend the Counselling-cum-admission for UG/PG and Ph.D. Courses in the Institute from the next Academic Year.

**Resolution:** *Approved*

**AC. 33.12 To consider the proposal for 2<sup>nd</sup> Round of Counselling- cum -Admission for PG Courses from next Academic Session.**

[Note: As per the norms of the Institute, the admission to the PG programme is conducted according to the results of NEPGET. The results of the NEPGET are prepared by taking into consideration the cut-off marks and the reservation policy of the Govt. of India. The results of PG Courses are published for Selected List and 100% Wait List and there is no 2nd Round of Counselling- cum-Admission for PG Courses. It is seen and experienced from the past that due to non-availability of particular categories of the candidates, the seats remain vacant and unfilled. Further, since the unfilled seats are not carried over to the next year, there is a visible impact on the total enrolment of the students as seats remain vacant. The problem gets compounded further with the withdrawal of some candidates post admission. This, in turns, deprives many students who have qualified the NEPGET and willing to take admission into the PG programmes. Once a 2nd round of Counselling with Open Merit gets implemented, it will significantly address the issue of low intake (Parameter 1.a) which has been flagged during the successive NIRF ranking reports for NERIST.

Therefore, it is proposed that in the results published for P.G Courses should also contain 200% Wait Listed candidates for each category as per the reservation policy adopted by the Govt of India. Further, an Open Merit List (200%) needs to be published by following the cut -off marks in NEPGET for 2nd Round of Counselling- cum- Admission. Similarly, the provision for having Spot Round for filling the remaining vacancies may also be explored. The detailed agenda is placed at **Annexure XII**.

**AC. 33.13 To consider the proposal for new method of Counselling for NEE and NEPGET**

[**Note:** Dr Arnab Bandyopadhyay, CoE has submitted a proposal for the new method for NEE and NEPGET Counselling. As a member of the counselling committee for about five years now as technical member, the Dr Arnab has opportunity to passively observe the following problems in the present method of NEE and NEPGET counselling. Therefore, he proposes an **alternate counselling method as a solution**. The broad outline of the same is listed in the proposal. Finer details may be worked out, if the Council thinks this proposal has some merit. There should also be a **spot round** at the end, both for NEE and NEPGET.

**Resolution:** *Existing Counselling cum Admission system shall continue. However, a counselling guidelines needs to be drafted under the Chairmanship of Dean (Academic)*

**AC. 33.14 To report about the fixing of the date of 8<sup>th</sup> Convocation**

[**Note:** It is to inform that the 7<sup>th</sup> Convocation of the Institute was held on 19.11.2018 and due to the administrative reasons and the Covid-19 Pandemic situations in the country, the convocation for the last 3 years couldn't be held. A meeting was convened by the Director on 26.11.2021 with all the Deans, HoD/HoC, CoE, Officers, Chairpersons, Coordinators to discuss the feasibility to conduct the 8<sup>th</sup> Convocation. Dean (Acad) has proposed the date as **18.02.2022 (Friday)** and all the members has accepted and supported the date for the conduct of the 8<sup>th</sup> Convocation. However, in the meeting it was also discussed that the role of Chairman, BoM in the Convocation which is very important and crucial but at present Institute is running without Chairman, BoM. Hence, Academic Council may decide the protocols to be followed for the conduct of 8<sup>th</sup> Convocation of the Institute on 18.02.2021]

The Academic Council may like to deliberate and decide.]

**Resolution:** *Noted. However, it was decided that in absence of the regular Chairman, BoM the Academic Council suggested that the Director, NERIST may sign all the certificates and also complete the modalities of the Convocation. However, the matter was also referred to the BoM for suggestions.*
