Sub: Acceptance of Base Module certificate of NERIST for employment

Sir,

This has reference to the letter received regarding the employment of Mr. Shyamtanu Chaudhuri in Oil and Natural Gas Corporation - Company (ONGC) for the post of Jr. Fire Supervisor. The applicant has submitted that the basic qualification for the post is Intermediate or equivalent and ONGC while verification of Base Module Certificate from North Eastern Regional Institute of Science and Technology (NERIST) has rejected his application saying that his qualification is not equivalent to 10+2 qualification.

In this regard, want to drawn to the fact that Mr. Shyamtanu Chaudhuri pursued B. Tech degree from NERIST in 2010 in 10+2+2+2 pattern. NERIST is a deemed-to-be-university, autonomous, fully administered by the Ministry of Education, Gol.

The Base Module Programme of NERIST has already been considered equivalent to 10+2 stage qualification by the Ministry of Human Resource Development, Department of Higher Education, Gol vide letter No. F.No.9-3/2020-TS VII dated 11th February, 2020. The NERIST was intimated regarding equivalence of its program by the Ministry of Education as per AIU letter No. EV/(731)90/183684 dated 05/03/1991, which is reproduced as below: -

"this is to certify that Institute's Base Module leading to Certificate in various trades has been recognized by Government of India for the purpose of employment. The Association of Indian Universities (AIU) vide their letter No. EV/(731)90/183684 dated 05/03/1991 has accepted it as a recognized programme comparable to +2 stage qualification".

In view of above, it is requested that Base Module Certificate issued to Mr. Shyamtanu Chaudhuri by NERIST may be accepted as equivalent to Grade 12 examination.
