NOTIFICATION

It is hereby informed to all students of NERIST that reference is made to Clause 2.6.1 of the Undergraduate Bylaws and Notification No. ACAD/SR/09-10/153(PART) dated 03/01/2025, which mandates that every student must maintain a minimum of 75% attendance in lectures and tutorials, and separately in laboratory, workshop, and drawing classes held for each course in which the student is registered. Failing to meet this requirement may result in the student being debarred from appearing in the End Semester Examination.

Further, Clause 2.6.6 clearly states that students with a shortage of attendance shall be awarded an 'FA' grade and debarred from appearing in both the End Semester and Supplementary Examinations of the concerned courses.

After careful examination of the students' attendance data up to May 1, 2025, the following decisions were made regarding the implementation of the above clauses:

- 1. As a one-time exemption for the current semester, students with overall attendance above 50% will be allowed to appear in the End Semester Examination.
- 2. Furthermore, it has been decided that if a student obtain 75% or more attendance in any specific course(s), even if his/her overall attendance is below 50%, he/ she will be permitted to appear in the End Semester Examination in that/those course(s) only.

Please note that this exemption is applicable only for the current semester and shall not be treated as a precedent for future cases.
