
Congratulations! Based on your performance in NEE-2026, you are placed in the selected/waiting/extended list of NEE-I/NEE-II/NEE-III for admission for the Academic Session 2026-27. **Please follow the attached schedule for Counselling/admission. You are required to follow the schedule till the completion of the admission process. Requests for any changes or deviations from the schedule shall not be entertained.** The admission of wait-listed candidates is subject to the availability of vacant seats after admission of the selected candidates. **The admission of the Extended Wait-listed candidates is subject to the availability of vacant seats after admission from the waiting list.** The 2nd round of Counselling/Admission shall be available only for candidates whose names are included in the 2nd Round Open Merit List and shall be subject to vacancy, if any, to be notified on **07.07.2026**. Further, **Spot Round of Counselling-cum-Admission** shall also be available for a day on **15.07.2026**, subject to the availability of vacancy, if any.

You are, therefore, invited to **fill up the Counselling-cum-Admission form by registering at <https://students.targetx.in/NERIST/> from 1st June 2026 and by making a payment of ₹1,500/- (non-refundable counselling fee).** Candidates are required to submit the completed form at least one day before the respective scheduled counselling date and attend **PHYSICAL Counselling** for admission to the Institute as per the counselling schedule. **You must register with a valid email address and mobile number as all the correspondence will be made to those contacts.** These email and mobile numbers will be considered as your registered contact with NERIST if you are admitted here.

You will be required to bring the following documents while filling up the counselling-cum-admission form:

1. Class X, XII, and Diploma Pass Certificate, as applicable; Migration Certificate, Institute Leaving Certificate, Mark Sheets of all Semesters of Diploma, etc. Aggregate Marks for NEE-III in Diploma 3 Years should be 60% or above.
2. SC/ST/OBC/EWS/PWD certificate (if applicable) issued by the Competent Authority (Deputy Commissioner or an Authorized Revenue Officer) in support of your claim. *PWD candidates must bring the proper Medical Certificate clearly mentioning the locomotor disability and its percentage. The NCL/EWS Certificate should not be older than a year from the date of issue.*
3. A Permanent Resident Certificate (PRC) is mandatory if you have applied for the state quota of the North East Region. The certificate should be issued by the Competent Authority (Deputy Commissioner or an Authorized Revenue Officer) and bear the name, designation, signature with date, and office seal of the issuing officer.
4. Aadhaar Card of the candidate.
5. SBI Bank Account No. with a photocopy of the Pass Book, if available or else the student is required to open a bank account in the SBI after admission.
6. Legal Guardianship Certificate/Affidavit from first class magistrate, if applicable.
7. Parent/Legal Guardian's Income Certificate from the Competent Authority of the respective District.
8. Medical Fitness Certificate of the candidate as per the format attached.

If you encounter any problems during form completion, click on the "Query" button at the bottom of the left panel to raise a query, and we will respond to it through your registered email. Also, keep checking the Instruction and Notification sections on the left panel and the NERIST website (<https://nerist.ac.in>) regularly for updates.

The following points are to be noted in connection with counselling/admission:

- (i) **Not filling up Counselling-cum-Admission form before the scheduled counselling date/time and/or your absence in offline counselling on the prescribed date and time will be presumed as “Not Interested” in getting admitted to this Institute, and accordingly, your candidature will be forfeited for admission automatically.** In such case, no requests for further consideration shall be entertained in any form.
- (ii) Any deficiency in the documents, as stated above, will lead to the rejection of your candidature.
- (iii) **All the documents will be verified before admission. In case of any deficiency in your documents at the time of admission or furnishing forged/false/incorrect statements/documents at any stage after your admission/registration to this Institute will lead to cancellation of your admission.**

For admission to the available branch, according to your preference, the candidate must pay the following fees ONLINE immediately upon allotment of a seat during counselling.

- (a) Admission fee of **₹22,100/-** (approx.) for Certificate Courses, **₹26,200/-**(approx.) for B.Tech/B.Sc Courses & **₹29,500/-** (approx.) for BBA Course need to be paid after allotment of seat at the time of counselling cum Admission. Payment shall be made through ONLINE mode only by logging into the same account at <https://students.targetx.in/NERIST/login>. We accept all forms of online payment (Credit Card/ Debit Card/ Debit Card/ATM Card/Net Banking/ Wallets/ Cash Cards/ UPI (for a full list of supported UPI Apps, refer to <https://www.npci.org.in/what-we-do/upi/live-members>).
- (b) Mess Advance of **₹16,610/-** (approx.) and Hostel Caution Money of **₹3,000/-** by logging into Institute ERP (<https://nerist.symphonyx.in/student>) after hostel allotment. **Institute will provide you with the login credentials for NERIST ERP via SMS/email to your registered mobile number/email address after admission.**



REQUIREMENT OF DOCUMENTS & FEES FOR NEE 2026 QUALIFIED CANDIDATES AT THE TIME OF COUNSELING CUM ADMISSION - 2026

1. Class–X, XII & Diploma Pass Certificate, as applicable, Migration Certificate, Institute Leaving Certificate, Mark Sheets of all Semesters of Diploma, etc. Aggregate Marks for NEE-III in Diploma 3 Years should be 60% and above. **In case of non-availability of the Migration certificate or Transfer Certificate at the time of admission, the same has to be submitted within 40 (forty) days from the date of admission to the Institute.**
2. SC/ST/OBC/PD/EWS certificate (if applicable) issued by the Competent Authority (Deputy Commissioner or an Authorized Revenue Officer) in support of your claim. PWD candidate *must bring a proper Medical Certificate clearly mentioning the locomotor disability and its percentage. The NCL/EWS Certificate should not be older than a year from the date of issue.*
3. A permanent Resident Certificate (PRC) is required if you have applied for the state quota of the NE Region. The certificate should be issued by the Competent Authority (Deputy Commissioner or an Authorized Revenue Officer) bearing the name, designation, signature with date and office seal of the issuing officer.
4. Aadhaar Card, if any, of the candidate with a photocopy
5. SBI Bank Account No. with a photocopy of the Pass Book, if available or else the students are required to open bank a/c in the SBI after admission.
6. Legal Guardianship Certificate/Affidavit from first class magistrate, if applicable.
7. Parent/Legal Guardian's Income Certificate from the Competent Authority (Can be submitted within 40 days after admission)
8. Medical Fitness Certificate of the candidate as per the format available on the Institute website

After admission , the admitted students are also required to fill out **(to be submitted within 40 days after admission):**

- a) Online Anti-Ragging Undertaking on either of the following websites: www.AMANMOVEMENT.org or www.ANTIRAGGING.in. The hard copy of the undertaking, as received by email, should be submitted to the Academic Section and Nodal Officer Anti-Ragging at the time of semester registration every year.
- b) Anti-Drug Declaration Form to be signed by the student (as per the format attached).


You are also advised to bring one set of self-attested photocopies of all the above documents. The following points are to be noted in connection with counselling/admission.

- (i) Your absence in counseling on the prescribed date and time shall be presumed as **“Not Interested”** in getting admitted to this Institute and accordingly your candidature shall be forfeited for admission automatically. No requests for further consideration shall be entertained in any form.
- (ii) Late reporting on the scheduled date and time shall lead to losing your preference for the desired branch and admission. In such case, NERIST will not be responsible.
- (iii) Any deficiency in the documents as stated above will lead to the rejection of your candidature.
- (iv) In case of any deficiency in your documents submitted at the time of admission or found false or furnishing false/incorrect statements/documents at any stage after your admission/registration to this Institute, your admission shall be cancelled forthwith.

Fee Details:

For admission, the candidate shall be required to bring/pay the following amount on the date of counselling.

- (a) Admission fee of **₹22,100/-** (approx.) for Certificate Courses, **₹26,200/-**(approx.) for B.Tech/B.Sc Courses & **₹29,500/-** (approx.) for BBA Course need to be paid after allotment of seat at the time of counselling cum Admission to be paid **online** by following the link given on the Institute website after verification of the documents .
